The engine of the Whole Child program is the *Profile*. A simple but detailed questionnaire that is completed with the assistance of a trained Whole Child Advisor or community



partner, the profile creates an all-inclusive computerized outreach to all relevant local providers based on the needs identified in the profile. In the Tri-County area, Whole Child Advisor Tonya Bell, who also serves as Community Health Educator for the Coalition, continues to receive great praise for her grassroots effort to connect clients to the new resource. Having conducted hundreds of profiles as the system was being developed, Tonya can assist both clients and providers utilizing the system.

Tri-County Attends Whole Child Florida Annual Conference

During the Whole Child Florida Annual Conference held on June 9-10, representatives from Whole Child Tri-County, which covers Jefferson, Madison and Taylor Counties, listened in amazement as Dr. Peter Gorski discussed the newest research regarding child development, particularly findings regarding the early years from conception to pre-school. The

presentation left the group of advocates speechless but motivated, as Dr. Gorski carefully outlined the vital and irreplaceable role that parental choices play during those key years that establish lifelong conditions for the child.

Originally trained in Pediatrics and Child Development at Harvard Medical School, Dr. Gorski is the Director of Research and Innovation at the Children's Board of Hillsborough County, Professor of Public Health, Pediatrics and Psychiatry at the University of South Florida and President-Elect of the Society for Equity in Child Health and immediate Past President of the Florida Infant Mental

Health Association. From 2003-2006, Dr. Gorski served as the Director of the Lawton and Rhea Chiles Center for Healthy Mothers and Babies at USF. It is also the Chiles Foundation that founded and now spearheads the expansion of the Whole Child program throughout Florida.



Proceeds from MLK Jr. License Plate Benefit **Maternal and Child Health Organizations**

The Florida "Live the Dream" specialty plate became available in 2005 and costs \$25, with proceeds going to the Dream Foundation. The Dream Foundation then distributes the money between the Sickle Cell Disease Association of America, the Community Partnership for Homeless, and two maternal and child health organizations: the March of Dimes, Florida Chapter and the Florida Association of Healthy Start Coalitions.



Whole Child Tri-County: Jefferson, Madison and Taylor Counties Community Report

The Whole Child project in the three-county area was launched in early 2008. The project has been championed by the Healthy Start Coalition, which serves the three counties, and is staffed by a part-time employee whose role is to coordinate the meetings of the committee and follow-up on initial tasks. Whole Child IMT launched the "Whole Child Connection" in early 2009.

Strengths

Champion is the Healthy Start Coalition, which sees the Whole Child work as a natural fit.

Alignment of Healthy Start Coalition work with the Whole Child model of family outreach and holistic service delivery.

Start-up energy is still strong and the steering committee is enthusiastic.

Business community is engaged.

Challenges

The three rural counties lack some capacity that is needed to build a stronger Whole Child project; particularly at the community leadership level.

Funding only allows a part-time coordinator, and as the project demand increases more staff time may be necessary.

Reliance on one champion at the Healthy Start Coalition may cause funder burn-out and put project at risk.

Need to increase leadership for project.
