Effective March 2019, the program is new and improved. The goal of Healthy Start is still to reduce infant mortality, reduce the number of low birth weight babies, and improve health and developmental outcomes.

Signed into law in 1991 under Governor Lawton Chiles, Healthy Start legislation calls for the screening of all Florida's pregnant women and infants to identify those at risk for poor birth, health, and developmental outcomes. *ALL* pregnant women regardless of their marital, economic, or immigration status are eligible to participate in the Healthy Start program if they are at high risk for a poor pregnancy outcome. This includes post-partum women and their infants up to age three.

Here's a summary of the new Healthy Start ...

Home Visiting New Benefits

The new Healthy Start program offers the following services through home visiting:

- Developmental Screening for infants up to age 3
- Interconceptional Education and Counseling services
- Screening and Intervention for Intimate Partner Violence
- Screening and Intervention for Substance Use
- Screening and Intervention for moderate Perinatal Depression

Home Visiting Continued

The same Healthy Start program still offers the following services through home visiting:

- Care Coordination and Outreach
- Breastfeeding Education by Certified Lactation Counselors
- Parenting Education and Support
- Smoking Cessation Assistance

The Healthy Start staff for Jefferson, Madison & Taylor Counties was trained on Feb. 4–5 and are excited about the new services being offered! Also, on March 20, a Service Delivery Planning kickoff meeting was held where several board members and direct service staff committed to a comprehensive Needs Assessment and work over the next two years to produce a strategic plan to improve maternal and child health in JMT.

Celebrating 13 YEARS OF ACHIEVEMENTS

The Day of Dialogue on Minority Health (DoDMH) brings church and faith-based leaders together from north Florida counties, along with health organizations, university faculty and students, as well as community leaders to identify health concerns, while examining the role of the church and sharing best practices for developing action plans that solve challenges to minority health.

DoDMH began in Leon County and now has expanded into eight, which are actively involved in planning faith-based community health programs. Over 1,200 people have attended a total of 12 events since 2007.

For 2019, Taylor County sponsored the Day of Dialogue on Minority Health XIII, which was celebrated on Feb. 23 at New Brooklyn M.B. Church located in Perry. In partnership with Healthy Start Coalition of Jefferson, Madison & Taylor Counties, the theme was "Knowledge Is the Key to a Healthier Me." A healthy lunch and fun exercises were part of the prizes and other giveaways!

Over 60 participants came out with the basic intention of making Taylor and surrounding counties healthier. The affair opened with Dr. Sinclair Madry Jr., pastor of New Bethel M.B. Church, which was

followed by the welcome by Mrs. Renita Malone, and then came the Day of Dialogue on Minority Health background and history by Dr. Fred Seamon, DoDMH chairperson. Keynote speakers followed.

Our keynote and platform speakers included Walter Niles, MPA, Office of Minority Health and Health Equity, and, promoting her "State of the Infant," was Donna Hagan, MBA, Executive Director, Healthy Start Coalition of Jefferson, Madison & Taylor Counties Inc.
